Mayor discusses city's fiscal future

It's been an interesting year for Mike Tracy. Former Police Chief Tracy has had to get used to a different management style as Mayor Tracy. "It's a different role from what I anticipated," said Tracy. "As a department head you get input from everyone and make your decisions. With the council you can't make any decisions until you get people from the council to go along with you."

And his adjustment has not been limited to the council. He's also getting used to people's varied perceptions about his role as mayor. "The most interesting thing about being mayor," he said, "is that people have such different views about your authority and power."

These days, Tracy's most pressing problem is the city's current fiscal health. While the worst of the city's financial problems has been dealt with, the council and the city manager are still wrestling with another looming deficit. Recently, Tracy announced that, given the city's current income and expenditures, the fiscal projection for 2012-2013 is a deficit between 1.8 to 2 million dollars. It means once again the city will have to find new ways to tighten its belt.

Why is the city still in the red? For Tracy, one important reason has to do with employee retirement contributions. He feels that city employees are not contributing enough of their own income. "We are committed as a council to getting our employees back on track paying their share of their employee *Continued on page 3*

The 2012 Corporate Games

Dating back to 1989, the annual tri-county Corporate Games have been known to be the premier business-to-business team sports competition. Businesses from throughout the Ventura and Santa Barbara Counties compete for awards and prizes over the six-week long event in games like golf, bowling, beach volleyball, tug-o-war, and sandcastle building.

Since size is an issue that comes greatly into play, the companies are split into divisions based on their size. Corporate Games has two awards per division, plus Spirit Awards given to teams that show sportsmanship: the Overall Point Winner and the JD Probasco Spirit Award. Additionally, companies that take part in a Community Service Project receive

points toward the Team Unity Award. To go along with the Community Service Project, there is a sponsor to support it, and this year it's Time Warner Cable.

As the games began in 1989, only nine companies were involved, competing in six events held over a two-week period. Last year, roughly sixty companies and nearly 10,000 employees participated in the six-week Corporate Games. 2012 only brings new faces to the Games, consisting of sixty-two participating teams who are competing in thirty events throughout the six-week period. The 2012 Corporate Games is scheduled for March 28th to May 12th, and will kick off with a Welcome Reception at Spanish Hills Golf and Country Club a Continued on page 3

Kow(dog?)abunga!

Buddy Hooker is a typical 14 year old from Southern California. He likes to spend time with his family, "hang" with his friends and jump on his surfboard when the waves are just right. The only difference between Buddy and most other surfers is that he has four legs and is known as a high spirited Jack Russell terrier.

Buddy started out as a runner and by the time he was two, he was averaging 70 miles a week and had developed incredible stamina. At that time, he went to the beach with the rest of his adoptive family - Bruce, Leslie, and their two children, Megan and Matthew. Megan was boogie boarding and when her board floated into shore, Buddy jumped on. According to Bruce, "I took Buddy out a little farther each time we surfed, and started letting go of the back of the board after we had ridden the wave for a distance. Each time I would let the board go with Buddy on it sooner and sooner, and let him ride the wave by himself. Buddy learned through trial and error, and several wipeouts, that he needed to adjust to the board and the wave. With time, he learned to move back and lay low for takeoffs, then, after he rode the wave a distance, he could stand up and move forward on the board." Surfer Lee Priebe says, "Buddy is the best surfing dog in SoCal. He's almost human!"

In 2004, Buddy really got good and

his surfing got all sorts of attention. As Bruce notes, "He got a picture in the local newspaper for ripping up the world famous Surf Rodeo." Buddy also got to film a pilot working with Amazing Animal Actors for Animal Planet where he experienced his worst wipeout while training for the show. "We were tandem surfing on a 3-4 foot hollow wave and pearled (accidentally driving the nose of the board underwater, generally ending the ride). Buddy got sucked down and did not surface for several seconds. I thought I had drowned the poor dog, but then he popped up in the turbulent water gasping for air. That is when we found Buddy a life jacket with a handle on the top for safety."

Buddy has won the Helen Woodward Animal Center dog surf-a-thon five out of the past six years. He won this year, and was named the first dog in their dog surfing Hall of Fame. He also won the Lowe's event in 2010, along with the Purina 1 Extreme Dog Challenge in 2010. He's been seen on dozens of TV shows and in magazines all over the world and has developed quite a following. He has retired from dog surfing competitions, but still plans on surfing at his favorite breaks in Ventura as soon as the weather warms up in April. contribution," said Tracy. "We need to revise employee contracts to get them to pay the entire share of their retirement con-

Tracy also feels that Ventura has been reticent to develop revenues from new business and housing. "Over the years, we haven't been as proactive about building our retail base as cities like Camarillo and Oxnard," he said. "Oxnard and Camarillo have also been more aggressive about building higher end housing. And we haven't been as aggressive about bringing in larger businesses."

Why such a hesitant attitude toward growth? Tracy believes that Ventura's character is more conservative than other cities in the county. "Ventura historically has been reluctant to embrace change," he noted. "And that's within the community as well as the city government."

Addressing Ventura's reputation as a difficult business climate, he asserts that the key to solving the city's business woes is to provide a consistent set of guidelines. As he explained: "I think it's important for businesses coming to Ventura to know what the rules are and what to expect."

But he believes that establishing these guidelines is complicated by the city's location as a beach town, particularly its relationship with other agencies such as the California Coastal Commission and California State Parks. "So much of our downtown and west end fronts the beach," he said. "The fact that so much of Ventura faces the beach makes it more complicated to do development."

Still, he thinks there have been significant improvements in the city's approach to business; for example, within the city's community development department. "I would say it's improved from a few years ago," he said. "It's something we have to be constantly aware of and continually refining. I think Jeff Lambert has revitalized that department. The counter experience is more efficient than it used to be."

Tracy cites recent improvements with the city's local business partners. "There's the relationship between the city and the chamber of commerce," he said. "I think the willingness of the city to work with the chamber and the business community and make them successful has improved."

He also believes the relationship with the Downtown Ventura Organization is on the upswing, especially since they hired former Ventura County Star correspondent Kevin Clerici. "Kevin is a tremendous asset," said Tracy.

In terms of local business development, Tracy believes the city should expand the area around the city's auto mall. "The council is focused more than anything else on the area around

the auto mall," he explained. "I'd like to see it become a retail destination for the region."

In the short term, however, the city must solve its current budget deficit. "What we've asked the city manager to do is look at possible ways of reallocating existing revenues."

For Tracy, one of his priorities will be to address the city's recent increase in crime. "I do think we need to review our operations and reprioritize our commitments to public safety."

City reaches agreement with Pierpont over sand removal, part 2

As a result of the lawsuit settlement, the city has agreed that, starting March 2012, they will begin doing sand removal at Pierpont Beach. Shaw Contracting, a firm from Carpinteria, has been selected to remove an estimated football field's worth of sand two

stories high.

Asked who will pay for this cleanup, Rick Raives (the city's director of public works) replied, "It comes directly out of the city's budget. It comes out of the general fund." He estimated total contractor's cost at about \$550,000, but with contingency, inspection, and previous legal costs, the total will probably add up to about 1 million dollars.

In addition the public works department has agreed to begin sand removal in front of all lane end turnouts in the Pierpont Beach area, plus the 15 residences involved in the lawsuit. As Raives explained, "We've agreed that twice a year in the future, May and November, we will do an inspection of how much the sand has built back up against the walls, public and private, and if we feel a need, we'll send a contractor out to remove it."

Key to this is the city's judgment about the necessity for sand maintenance. According to the agreement, it falls on city inspectors to determine whether or not a "need exists to remove and/or contour the sand in accordance with the terms of the judgment to a level below the tops of the residents' retaining walls and fence to a level equal to that of the foundations of the residents' homes."

If the city determines that homeowners need maintenance, they are required to provide them with a 14-day notice prior to the start of work and include a good faith estimate about the cost of the work.

Once homeowners have received notification, they can opt in and pay for 50% of that maintenance. "The 15 property owners who have signed the agreement have agreed to pay for half of the cost of sand removal in front of their properties," said Raives. "The city is still responsible for 100% of removal on the beach in front of the lane ends, but if the city removes it in front of their property, they've agreed to pay for half."

If there is any disagreement between the city and the 15 Pierpont property owners regarding whether or not work needs to be done, the property owners have agreed to negotiate with the city to amicably settle the dispute. If an agreement is not reached, these property owners have the right to go back to court.

The agreement also stipulates that if any of the 15 property owners want to pay to have sand removed from in front of their property (when the city has not scheduled sand removal), they can apply to the city for a no-cost permit to remove sand according to the terms laid out in the settlement.

As for other property owners not involved in the lawsuit, Raives has left the door open to more negotiation. "We'll do the total removal the first time, but we only have a legal responsibility for the 15," he said. "However, we're also open to discussing the 50/50 split with the other property owners."

Looming in the background is the environmental impact of all this sand removal. Raives noted how the city is taking extra measures to address that issue. "Even though we don't have to," he said, "we're hiring a biologist, who will help us relocate up to 50% of any native dune plants and be available to us during removal of the sand to determine if any sensitive species are discovered."

While the agreement puts in place a plan for sand removal, Pierpont resident Murray Robertson does not see this as a final resolution. "They are going to have to do a longer term maintenance plan for the beach which includes not only Shore Drive but the

state parks portion," he stated, "and it should be interdepartmental-where all the stakeholders, the city, the state beach, the Coastal Commission, and the Pierpont Community Council have input. And the people of Pierpont should be the stewards of the beach."

Honoring a community icon

How do you show gratitude and honor someone who has devoted more than 38 years of their life to a cause that benefits others? In reality, you really can't because no amount of applause, testimony or recognition can begin to equal what Charles M. Hair, MD has done for our community.

Dr. Hair spent his early years in Santa Paula and graduated from Santa Paula Union High School in 1937. He continued on at USC and earned his medical degree in 1945. After internship and residency, Dr. and Mrs. Hair returned to Ventura County, where he became the epitome of family medicine and started a successful family and obstetrical practice.

It was in 1974 that Dr. Hair cofounded and became Chairman of the Livingston Memorial Foundation, which was formed in memory of the pioneering Oxnard physician Dr. Robert Livingston. With Dr. Hair at the helm, the Foundation allocated grants to several Ventura County agencies and thus began his diligent quest to provide care to those most in need.

In 1984 he was appointed Chairman of the Board of Livingston Memorial Visiting Nurse Association. With unlimited energy and commitment, Dr. Hair has also served as Chief of Staff at St. John's Regional Medical Center, on numerous civic organizations, committees, board memberships, and awards have Dr. Hair's name on them but this space prevents their listing. Dr. Hair also served in the U.S. Army Medical Corps from 1942 until his discharge as a Captain in 1947.

Now, after years of tireless devotion, Dr. Hair is stepping down and relinquishing his post to Laura K. McAvoy, a partner with the law firm of Musick, Peeler & Garrett LLP, who has been an enduring presence on the Livingston Memorial Board of Directors since 1984. Dr. Hair's tenure is far from over however, for his presence and service will continue in his role as honorary Chairman Emeritus.

His innumerable years of dedication, care and commitment have made Ventura, its citizens and the medical profession better off today ...a glowing tribute to Dr. Charles Hair and a life well lived.

This is only a test...

On February 9th a large-scale U.S.A.R. (Urban Search And Rescue) drill took place in Oxnard. This annual and regional exercise lasted for 14 hours and involved personnel from several fire departments across the area. Participating in the drill were three Fire Departments from the Ventura County area, including Ventura City Fire, eight departments from Santa Barbara County, as well Long Beach Fire and three FEMA K-9 search teams.

The goal of the exercise was to simulate and test coordinated responses from the region to an earthquake related incident. Live victims were placed within an actual collapsed commercial building prior to the exercise, eventually having to be located, triaged, and rescued in real-time. Many specialized skills were

tested including structural shoring, breaching concrete slabs, using rescue search cams and listening devices, vertical rope rescue, and specialized paramedicine used to treat victims of crush injuries.

wish to get involved with and support the emergency preparedness of their community, can sign up and participate in several local CERT (Community Emergency Response Team) programs. CERT is an approach by FEMA to involve citizens in emergency preparedness, and is funded through the U.S. Department of Homeland Security. Ventura City was the first in the County to initiate this course in the 1990s, and grant funding is allowing us to bring back this valuable curriculum.

CERT training provides the basic response skills needed to assist others in the neighborhood or the workplace during a disaster. These skills prove critical to the safety of our community as a whole when such an event does occur. During a large-scale event, professional responders will not be able

> their families, and their community. CERT students will receive approximately 20 hours of hands-on training from the Fire Department and other emergency management professionals. The training provided includes disaster and emergency preparedness, fire safety and suppression, disaster medical triage and treatment, light search and rescue, organization and team management, and disaster psychology. At the end of the course there is a live disaster simulation, after which graduates receive a starter kit and a certificate. Additional training opportunities, continuing education, and periodic refresher drills are also being provided.

Classes are held twice each year, one in Spring and one in Fall. Ventura residents of all abilities, 18 years of age or older, are welcome. School staff, workplace employees, scouting organizations and other similar groups that are committed to serve our community are also encouraged to enroll. CERT programs are free of charge and the next class in Ventura begins March 7th.

The ability to assist your neighbors and co-workers during a disaster, or any type of emergency, no matter how small, is an important skill. Are you ready?



Restaurant review

Tutti's Off Main

Located in the Livery Courtyard in downtown Ventura, the secluded location provides peaceful shelter from the bustle of Main Street. Tutti's reminds me of a Napa Valley ranch or Tuscan villa. Stone and smooth concrete walls combine natural and modern elements with the minimalist décor. Floor to ceiling windows and doors provide natural light and access to the garden style patio. A large table situated in the center of the restaurant is perfect for large groups. The small bar and wood-burning pizza oven located towards the rear of the restaurant adds a nice casual feel to the overall design. The patio is esthetically pleasing with natural shade provided by citrus trees intertwined into the trellis overhead. Live acoustic music is a common amenity offered here, significantly enhancing the dining experience.

Although my overall experience with Tutti's was enjoyable, there are three issues that are certainly worth mentioning, as they were mentioned by all of my guests during each of my visits. The issues are offsite restrooms, complicated menus, and slow and seemingly inexperienced service. The offsite restrooms, shared with the neighboring businesses, are located in a small corridor directly across from the entrance, require a key to access, and could have been cleaner. The menu is doublesided pages held to a wooden board with a rubber band. All of my guests complained about the unusual menu and the need to disassemble it just to read it. The slow and seemingly inexperienced service could test even the most patient persons' limits. The staff is very friendly, but also very likely to make mistakes. Thankfully, the exceptional food at Tutti's was enough to forgive its shortcomings.

The food here is superb. I sampled items from nearly every category of the menu and was pleasantly surprised by the presentation and flavor of every dish. The rack of lamb (encrusted with pistachio and seasoned bread crumbs - \$34), offered as a special during one of my visits, was by all accounts truly special. The lamb was tender and juicy and the pistachio crust provided the perfect flavor accompaniment to this delicate meat. The menu contains something for everyone. including an excellent variety of pizzas with fresh ingredients. I really enjoyed the mushroom pizza (sautéed shitake, portobello, and cremini mushrooms with ricotta, gorgonzola, and mozzarella cheese - \$13.95 lunch price). Although the gorgonzola may be a bit overpowering for some pallets, I felt the slightly sweet pizza crust helped balance the bold flavor of the cheese. The lunch menu features a variety of delicious sandwiches served on fresh bread, including the churasco (grilled chicken breast, roasted pepper aioli, roasted pasilla chile, and cheddar cheese on grilled focaccia - \$11.50). Served with a mixed greens salad, homemade potato chips, and delicious white bean and risotto salad, this sandwich is a deliciously great value for lunch. Save room for dessert. especially for the classic cannoli; the best cannoli I've ever had.

All things considered (food, atmosphere, and service); I give Tutti's Off Main four forks. To decrease the likelihood of frustration with the slow service, visit Tutti's with plenty of time on your calendar and patience in your heart. The food is worth the wait.

The Ventura Hillsides Conservancy (VHC) has announced the hiring of a new executive director.

Melina Sempill Watts will serve as director of the Conservancy on a

other current position as Santa Monica Mountains Watershed Coordinator. Watts currently lives in Calabasas and will commute to the Ventura office two days a week.

Watts' conservation background includes seven years working at the Resource Conservation District of the Santa Monica Mountains as the Malibu Creek Watershed Coordinator.

In addition, she has been a creative executive, writing consultant, and script analyst at such companies as Kennedy/Marshall Company, Pico Creek Productions, The Bedford Falls Company and DreamWorks. She graduated with a degree in history from UCLA.

How did a writer and film executive end up as a conservation director? "I was writing a novel based on 400 years of environmental history," said Watts, "and I took a class with Rosi Dagit, who is the premiere expert on oak trees in California. So she told me to check out the Resource Conservation District. They had a job opening for a biologist. What they thought they wanted was a biologist, but what they needed was someone to help pull people together and I'm really good at that."

What was supposed to be a temporary position has turned into a whole new career. "The position I walked into was funded for six weeks. I took a six-week position and it turned into eight years."

She feels a strong connection to Ventura. She's been visiting here since she was seven and has a special fondness for sights like Two Trees. "I've been in love with open space in Ventura for many years and joined the Conservancy as a member, so when this position opened, I saw it as my dream job."

She believes her most important role with VHC will be to focus on what the community really wants. "If something is important to the community," said Watts, "and you ask the community to help you, the money will come because people fund what they love."

Watts has already received inquiries for potential land trust acquisitions. "We have some exciting opportunities looming in the mountains, and what's really exciting is that people are reaching out to us. I've gotten some phone calls that have left my jaw on the floor."

Watts would like to strengthen the Conservancy's ties to some of Ventura's key historical communities. "We are looking forward to deepening our ties with the ranching and agriculture community, who are the reason there is so much open space in Ventura," she said. "We also hope to connect with the Latino community, who provide so much vibrancy here in Ventura."

Her background as a watershed coordinator will serve her in good stead here in Ventura. "From an environmental perspective, creeks and rivers are the lifeblood of any environmental system," she explained. "So the work that VHC has done to preserve and restore riverways is crucial to the overall ecosystem."

Why did the Conservancy hire her part-time rather than full-time? "Under their current budget, they thought it made sense to hire me parttime. As far as a full-time position goes, they're open to it, I'm open to it. The future lies ahead."

For Watts, her two jobs share common values and goals. "Both jobs are about serving the community, caring for the environment, and finding the money

part-time basis, splitting time with her to do the right things which, in the case of VHC, are the purchase of open land, providing public access, and restoring those lands to their native conditions."

> She believes that the future for the Conservancy is very bright. "There's so much beautiful land available to us," she said, "and it may not be available forever. I would say join VHC now as a member, do it for your children, do it for your grandchildren, do it for the land."

Ask the Director

Breeze: Who is responsible for picking up trash and debris to keep our city looking clean and

Lambert: Maintaining safe and clean public places is important to our community's environment, economic prosperity and quality of life in Ventura. The City is responsible for the removal of debris solely on public property that is serviced by the City, which includes parks, curbsides and public rights-ofway. We make it a priority to remove debris within 72 hours.

To better serve the community, a Debris Removal Hotline has been established for the public to report significant trash issues on property serviced by the City. Residents can call 677-3999 or log on to www.cityofventura.net/ mva and report the precise location of debris. The City provides monthly street sweeping in residential neighborhoods and commercial areas and trash barrels are provided at many public locations to keep our city clean.

Federal, State and County agencies service many areas in our community and the City works in collaboration with these entities to ensure that public places are maintained. The responsibility for debris removal is dependent on the site in which it is located.

Generally, State Parks and Recreation owns and is responsible for debris removal on beaches: south of the pier and north of Marina Park, South Beach jetty toward the Santa Clara River. In addition, State Parks is responsible for Emma Wood State Beach and the areas immediately adjacent to the bike path.

Caltrans is the State agency responsible for debris removal along, underneath and immediately adjacent to freeways- including medians and on and off ramps, Union Pacific Railroad owns and is responsible for debris and graffiti on and around the railroad owned property, and the Ventura County Watershed Protection District is responsible for the Ventura and Santa Clara River bottoms.

The California Shopping Cart Retrieval Corporation (CSCRC) is responsible for the retrieval of all shopping carts in the city of Ventura and can be reached at (800) 252-4613.

Debris on private property is the responsibility of the property owner. Residents can take advantage of the City's free, monthly Household Hazardous Waste Collection events to dispose of toxins by calling 652-4525 (Monday-Thursdays, 8-5pm) to make an appointment.

Ultimately, everyone is responsible for not littering. Many individuals in the community pick up trash during their regular exercise walks and in their neighborhood, these individuals are to be applauded. The City also provides volunteer opportunities to maintain and enhance our community through beach clean-up's and neighborhood projects. 

It's tax time!

It's that time of year again when men's legs start quivering and women's hearts begin beating a bit faster. No, it's not "Spring when a young man's fancy..." - you know that part of it no - it's TAX SEASON!

Here are some "fun" facts about taxes:

- In 1913 the tax rate was 1% on taxable net income above \$3,000 (\$4,000 for married couples), less deductions and exemptions. It rose to a rate of 7% on incomes above \$500,000.
- During World War I the top rate rose to 77%; after the war, the top rate was scaled down to a low of 25%.
- During the Great Depression and World War II, the top income tax rate rose again. In the Internal Revenue Code of 1939, the top rate was 75%. The top rate reached 94% during the war and remained at 91% until 1964.

Fortunately, there are two organizations who offer salvation to seniors and low income individuals and families - Community Action of Ventura County and The American Association of Retired Persons (AARP). The tax counseling for the elderly (TCE) program offers FREE tax help to individuals who are 60 years or older and low-income people who cannot afford professional assistance with their federal and state tax returns. This is made possible through grant funds, made possible by an appropriation of Congress. Volunteers attend classes to learn how to prepare federal and state tax returns, to update their knowledge on changes to the 2011 forms and to learn how to

do e-filing.

For those in Ventura, free tax preparation, prepared by AARP in conjunction with the Internal Revenue Service, is available on a "first come, first served" basis at these locations, days and times:



To receive help at both centers, people should bring their last year's tax returns, W-2s and 1099s, bonds, bank statements, etc., as well as year-end summaries from Social Security. The volunteers can handle most basic federal and state tax forms but they suggest that anyone with a business or extensive investments do hire an accounting firm who would be more knowledgeable in these areas.

Volunteer tax assistants at both centers have the capability of doing electronic filing online for both federal and state taxes and having refunds direct-deposited, provided that those seeking tax assistance bring in a deposit slip or voided check with their name and address.

Not everyone has the luxury of taking time out during the day to have their taxes prepared or the location may not work for you. If this is the case, call 2-1-1 for the Community Action of Ventura County days/times/locations or Ed Klein at 659-2448 for AARP alternative days, times, and various venues in Ventura County. Oh and bring a book as you may have to wait a while before your claim can be prepared, Love!



Woman in Black

Adapted from the book, *Woman In Black* by British novelist Susan Hill, this made for stage, television, and film psychological thriller stars Harry Potter famed Daniel Radcliff, who has proven to us that he can step out of the Potter character and into a new skin of a promising skilled actor.

The Woman in Black takes us to a dreary seaside village in Crythin, England where young London lawyer Arthur Kipps is assigned by his boss to finalize the affairs of a recently deceased woman. He is dropped off by carriage to Eel Marsh, a sinister and hauntingly hair

The story, its characters, underlying messages, plot shifts and positive ending, is a proven audience pleaser. What makes the show succeed or fail at the community theater level are the musical skills of the company, and this cast is up to the challenge.

Lynetta Ivey plays the pivotal role of Lizzie. She is a highly trained and seasoned vocalist whose extensive credits include numerous professional musical theater productions across the country. Her talent, training and expertise shine through.

As Starbuck, Jodi Wurts brings to the role all the essential characteristics. Starbuck has to be bigger than life, full of energy and charismatic. Big in stature, Wurts also fits the role both in personality and musical ability.

Another vocal highlight is the sonorous baritone voice of Larry Craig as Sheriff File. Nicholas Penrose, as Jimmy, and Ella Bowen as his teen love interest, Snookie, infuse their characters with the necessary enthusiasm and hormonal energy. Dale Alpert as the father, H.C. Curry, provides a sage counterbalance to the sibling squabbles among his offspring.

Most all of the action takes place in outdoor settings, which permits the inclusion of a large ensemble of characters and vocalists who enrich the show with their dedication and mushrooming theatrical skills.

This show is the inaugural production of the re-branded Camarillo Community Theater. The facility sports a facelift and the addition of a dedicated artistic director who has crafted an intriguing season for the balance of the year.





It took Ike to get Scott Gordon to move to Ventura

Introducing new WAV resident artist Scott Gordon

"It's as if I was meant to be here and it only took a category four hurricane to get me to realize and act on it!" So recounts Scott Gordon, a California native, who after 13 long years in Houston, Tx. has finally found himself home once again by the Pacific.

In 2008 Gordon had begun preparing for his 11th solo exhibition in Houston: what he hoped would be his magnum opus. He worked for a solid 18 months, produced a catalog and spent a small fortune preparing. Mother Nature had entirely different plans for Gordon and Houston in the guise of Hurricane Ike. "It was the second costliest hurricane in the United States and it landed on the night of my opening. It brought the city to a virtual standstill for months as the entire infrastructure crumbled," Gordon recounts. He watched his dreams dissipate with the receding wind and water. "People lost their lives and their homes. All I lost was a dream, but I was devastated nonetheless.'

It took him two years to recover, but during that time he began to hear and honor the quiet internal yearning that had always been there since leaving California – to come back home. The unassuming beauty of Ventura with its sparkling shores, its small town appeal, and its promise as New Art City appealed to Gordon. "It wasn't until I came here to visit a friend's mother in the Keys that I became smitten – 'I could live here' I thought, in fact...I want to live here!"

So he headed back to Texas; sold, donated gave away and discarded everything that would not fit in his Dodge Neon and promptly left Texas. "I had never done anything so bold, so daring, and so crazy."

He landed on Ventura's shores in August of 2010 without a job or residence at the ready and took the first of both that he could find. Hearing about the WAV, he submitted his application with the hope of taking root in the local community of Ventura artists.

"It was a dream come true" says Gordon, "15 months later out of 32 applicants from around the world, I was selected to join the WAV community this past October."

Gordon has been creating art for over 25 years and is represented by Hooks Epstein Gallery in Texas. He is in numerous public and private collections, both nationally and internationally. 


